OBJECTIVES OF THE COMMITTEE:

ROLES & RESPONSIBILITIES:

4. Monitor Anti-Ragging activities in the institution, considers the recommendation of Anti-Ragging squad and to take appropriate decisions.

PENALTY & PUNISHMENTS RELATED TO RAGGING:

Depending upon the nature and severity of the offence as established by the Anti-Ragging Committee of the college, the possible punishment for those found guilty of ragging at the college level shall be any one or any combination of the following:

3	Wrong fully Restraining or Confining or Causing Hurts	imprisonment up to 2 year or fine up to Rs 5000/- or both
4	Causing Grievous Hurts, Kidnapping or Raping un-natural	Imprisonment up to 5 years or fine up to Rs 10,000/- or both
5	Causing Death or Attaining Suicide	imprisonment up to 10 years or fine up to Rs 50 000/- or both
